



# NATURE IS JUDGING YOU

## CONTEST RULES

1. Contest: [Réseau plein air Québec](#) (RPAQ) and their brand [ON Y VA](#) is organizing a free contest with no obligation to purchase.
2. Duration of the contest and participation deadline: The contest runs from August 5<sup>th</sup> (at midnight). Entries must be received no later than 11:59:59 p.m. EST on September 8<sup>th</sup>.
3. Prize: **1 Québec caves book, 1 certificate for 2 adult visits to the Saint-Léonard cave during the 2024 season, 1 Vélo Mag subscription, 1 Vélo Québec membership, 1 small bicycle guide, 1 Québec sub aquatique membership, 2 Aventure Écotourisme Québec gift certificates worth \$50 each, 2 Association des parcs régionaux du Québec gift certificates worth \$50 each, 1 La Cordée gift card worth \$100. Approximate value of \$533.** The prize cannot be returned, exchanged, or subject to payment of its equivalent value in cash. Any challenge to the prize for any reason whatsoever will amount to a definitive refusal of the latter. The prize is neither exchangeable nor transferable. It cannot give rise to any dispute.
4. Participation: To participate in the contest, entrants must be 18 years of age or older on the day of the draw. The administrators, staff, and suppliers of RPAQ are excluded from the contest. The RPAQ may disqualify any person for serious reasons, most especially if they disrupt the running of the contest, violate the rules, or cheat.
5. Conditions of participation: To participate, Internet users must go to the "[Nature is Judging You](#)" website, answer the [quiz questions](#), and complete the registration form. One entry per person is accepted.
6. Winners: RPAQ will draw the winner from among the registrations received, during the **second week of September**.
7. Notification to winners: Winners will be notified by telephone or email during the first week of March. If the winner does not respond to the email sent to them or does not return the call within 24 hours, another name will be drawn. The winner will also be required to sign a release form in order to receive their prize.

8. Publication of the names of the winners: Following the draw, the name of the winning person may be published for up to one year in the various RPAQ communication tools, including, but not exclusive, its sites [reseaupleinair.quebec](http://reseaupleinair.quebec) and [onyva.quebec](http://onyva.quebec), its social networks, and its newsletters.

9. Dispute resolution: A dispute regarding the organization or conduct of a promotional contest may be submitted to legal counsel or to a court of common law. A dispute regarding the awarding of a prize may be submitted in such instances for the purpose of an intervention with the goal of resolving it.
